Update – Royal Commission into Violence, Abuse, Neglect and Exploitation of People with Disability

As you may know, the Royal Commission into Violence, Abuse, Neglect and Exploitation of People with Disability is now underway, and will hold further hearings next month, focussing on homes and living for people with disability in Victoria.

The purpose of this email is to give you an update and to let you know about additional sources of information and support that are available to you.

Oak Possability delivers 1.5 million hours of support a year to more than 900 people with disability, as part of our mission of creating a world where everyone has the opportunity to pursue their potential.

As I hope you are aware, we take violence, abuse, neglect and exploitation of people with disability incredibly seriously. Safeguarding the rights of our clients is a fundamental part of our culture, systems and processes.

Oak Possability welcomes the Royal Commission into Violence, Abuse, Neglect and Exploitation of People with Disability.

The Royal Commission will hold hearings and public consultations around Australia before producing an interim report by 30 October 2020 and a final report by April 2022.

Although some of the issues likely to be raised will be distressing, we strongly support the commission. It provides an important opportunity for people with disability to have their experiences acknowledged and will help to shape improvements in the disability sector.

Please be assured that we will participate in the Royal Commission in line with our values of humanity, innovation, honour and accountability.

We will be honest and open, proactively providing information and taking responsibility for any failings that might become known.

We will also advocate for systemic change in our sector where we believe this will benefit people with disability.

I want you to know that the wellbeing of our clients and staff is our highest priority. A counselling and referral service is available for people with disability, their families and carers, and anyone affected by the Disability Royal Commission.
